## Information for Mobile Food Vendor Holders

Stalls can be setup from 6am and must be ready to commence trade by 9am. There is no vehicle movement within the market & food stall area between 9am and 4pm. Pack up is from 4pm.

It is important that supply of food is available to attendees throughout all festival hours. Mobile food vendors must ensure their food quantities have to the best of their knowledge been prepared adequately for the attendee numbers provided by the festival organisers.

Applications must be received by 30<sup>th</sup> June, 2018 . Applications will be processed and bookings confirmed upon receipt of the completed application form, public liability insurance certificate of currency for \$20 million and payment.

Site fees may be paid by cash, cheque, money order or electronic payment, payable to Hilltops Council. Tax receipts will be issued to all stall holders.

There may be applications not accepted for reasons of duplication & limited numbers.

Mobile food vendors holders must supply all their own equipment and ensure it is properly secured. All electrical leads and equipment must be tagged and tested satisfactorily. Power lead tagging may be obtained from Robert Scott Electrical on the day for a small fee.

Each mobile food vendor will have a pre-allocated site determined by the committee.

Mobile food vendors are to dispose of all their own waste material into the bins provided around the Festival area.

Mobile food vendors must ensure they comply with guidelines for food businesses at temporary events. For example, Food Safety Supervisor Certificates should be available in the vehicle and the vendor must have notified their local council of their business and food activity details.

Stall fees are not refundable due to inclement weather conditions or cancellation by the stall holder within 7 days of the festival. However stall fees will be fully refunded in the unlikely event of the festival being cancelled.
